



## LONDON BOROUGH OF LEWISHAM Submission of Local Plans

The London Borough of Lewisham has submitted two Local Plans to the Secretary of State for independent examination as follows:

- **Lewisham Town Centre Local Plan** - a comprehensive set of policies and proposals for development in Lewisham Town Centre over the next 10 years, including major redevelopment opportunities and major traffic and transport infrastructure changes.
- **Site Allocations Local Plan** - identifies the locations and sites for specific types of development across the borough, ensuring the vision, objectives and spatial strategy of the wider Local Plan are implemented.

The Council have produced a schedule of recommended modifications to each plan following the publication of the proposed submission versions in order to respond to:

1. Representations received on the consultation of the proposed submission version in March / April 2012.
2. Changes to the national planning context following the introduction of the National Planning Policy Framework (NPPF).
3. Minor factual errors.
